The Queensland Trucking Association Road Freight Industry Awards are the industry's gala event of the year. The Awards recognise the outstanding calibre of people, businesses and initiatives that make up the road freight industry in Queensland.

Any financial member of the Queensland Trucking Association may nominate. This includes an individual, business or initiative, providing they meet the relevant Award Criteria.

Nomination Eligibility

- A Company or Individual dedicated to improving the trucking industry, through their commitment, operation or contribution to industry activities (Company or Individuals employer company must be a QTA member).
- Self-nominations for 'individual' recipients not accepted.
- Each nomination criteria must be addressed in the application.

Selection Criteria

- Describe the person's character, values, personality and interests (Individual Nominations only).
- Career history list employers, years served and position held (Individual Nominations only).
- Tell us about the Company's beginnings, history, relevant corporate achievements, values, culture etc (Company Nominations only).
- Demonstrate a long-term participation in road freight transport.
- Demonstrate personal and/or organisational commitment to achieving positive benefits for the industry through actions.
- A demonstrated reputation for integrity and ethical behaviour.

Nominations must to be accompanied by the below supporting documentation:

- Any additional documents pertaining to the achievements, awards, honours which the nominee has received or the committee/industry groups the nominee has been involved in with direct relevance to the award.
